5. You must provide your own Lighting (Fluorescent Bulbs only) and 50' Extension cords.

Vendors and Organizations terms and conditions

1. Tropic Fest shall be held rain or shine. No refunds shall be granted under any circumstance.

2. **One exhibitor is allowed per space. No selling or soliciting outside your assigned space.**
3. We will not issue any refunds should the City of Lake Worth or Greater Lake Worth Chamber of Commerce prohibit any vendor from participating in Tropic Fest for failure to comply with the Code of Ordinances for the City of Lake Worth, FL.
4. **All vendors are responsible for having the appropriate food licenses, and for collecting 6.5% Florida sales tax.**
5. **Health Department will inspect your booth prior to event for license and food handling requirements. One day license will be sold by inspector for those needing license.**
6. **No beverages or Alcohol may be sold or provided at any food booth.**
7. **All tables supporting cooking facilities will be of stable construction, so as to prevent any accidental knocking over by the public or vendors.**
8. **If you are using tables, please make sure they are properly covered. Absolutely no bed sheets allowed. Tablecloths only.**
9. **ALL FOOD VENDORS MUST COVER THE GROUND IN THEIR SPACE WITH A TARP, MATS, PLASTIC, ETC. TO KEEP GREASE CONTAINED AT ALL TIMES!**
10. **All cooking will be done in an open area and precautions will be taken to protect the public from having any accidental contact with the cooking areas. All food vendors must have an absorbent mat under cooking area to catch any spilled grease.**
11. **Vendors who will be cooking (charcoal, grease, etc.) will be required to have in their possession a 10 lb. fire extinguisher with a Class ABC rating. The extinguisher must be in serviceable condition or the vendor will be shut down until one is obtained.**
12. **ALL HOT COALS will be extinguished by the vendors prior to leaving the area. The vendor is responsible for proper disposal of coals. No Hot Coals will be allowed to be dumped into any trash container or on the ground. No ground fires are allowed on any City property.**
13. **NO DUMPING OF FUEL, COOKING OIL OR WASTE FOOD is allowed on street, park lawns or in street drains.**
14. **NO GLASS CONTAINERS are allowed for dispensing beverages.**
15. **All extension cords must be secured in a safe manner, with proper grounding prongs so as not to present a hazard to the public. Do not overload power strips. City electrician will inspect prior to event.**
16. Failure to comply with the above terms and conditions may result with in expulsion from Tropic fest and forfeiture of any application fees.
