Rules & Regulations

1. All items must be listed on application. Anything not listed may not be sold at the event.
2. One exhibitor is allowed per space. No selling or soliciting outside your booth space.
3. The event coordinator reserves the right to remove any exhibit that is deemed inappropriate or unacceptable.
4. No refunds – Rain or Shine.
5. Set Up: All vehicles must be removed from the park by 10:00 a.m.
6. NO GARBAGE, BOXES, ETC. MAY BE IN VIEW. Exhibitors must keep their space clean. All boxes must be broken down before discarding. All exhibits and materials must be contained within your allotted space. This policy will be strictly enforced.
7. All vendors are responsible for having the appropriate licenses, including City of Lake Worth permit and for collecting the 6% Florida sales tax.
8. NO BEVERAGES MAY BE SOLD BY ANY VENDOR.
9. NO handmade signs.
10. If you are using tables, please make sure they are professionally covered to the ground. Absolutely no bed sheets allowed – tablecloths only.
11. No political parties, committee, groups or organizations will be allowed to promote or distribute anything. No political materials can be distributed from a vendors' booth. The organizer of the event reserves the right to remove any material that we deem inappropriate whether political or otherwise.
12. No dogs allowed in park per City of Lake Worth Ordinance.
13. ELECTRIC IS PROVIDED FOR LIGHTING ONLY. You are required to bring your own lights, cords, etc. to illuminate your space (FLOURESCENT BULBS ONLY!!!) .
