By order of City of Lake Worth NO pets are allowed in Bryant Park.

If you bring a pet, city officials will ask you to leave the park. There are NO exceptions

DIRECTIONS

Bryant Park is located at the foot of the Intracoastal Bridge on Lake Avenue in Lake Worth. Take I-95 to 6th Avenue S. go east to Dixie Highway (US1). Go left on Dixie 6 blocks to Lake Avenue. Take a right on Lake Avenue and head east 8 blocks. Bryant Park is on the right in front of the Gulfstream Hotel.

1. Fee must be included with application.
2. Deadline for receiving application is **April 10, 2010**
3. Electricity is provided for your lights only. **You must provide your own Lighting (Fluorescent Bulbs only) and 50' Extension cords.** Contact our office if you need to bring a generator.
4. You will be notified by email.

Terms and Conditions

1. Reggae Fest shall be held rain or shine. No refunds or transfers shall be granted under any circumstance.
2. One exhibitor is allowed per space. No selling or soliciting outside your assigned booth space.
3. No refunds will be made for weather or unforeseen circumstances. We will not issue any refunds should the City of Lake Worth or Greater Lake Worth Chamber of Commerce prohibit any vendor from participating in Reggae Fest for failure to comply with the Code of Ordinances for the City of Lake Worth, Florida.
4. No political materials can be distributed from inside the event. The organizer reserves the right to remove any material that we deem inappropriate whether political or otherwise
5. **NO GARBAGE, BOXES, ETC. MAY BE IN VIEW.** Exhibitors must keep their spaces clean: boxes broken down before being discarded and must be contained within your assigned space. This policy is strictly enforced.
6. All vendors are responsible for having the appropriate licenses, and for collecting 6.5% Florida sales tax.
7. No beverages may be sold or distributed by any vendor unless specifically approved on the application.
8. No vendor will be permitted to use any electronic sound, electronic amplification or musical devices at any booth without prior written approval.
9. If you are using tables, please make sure they are professionally covered with tablecloths only. Absolutely no bed sheets allowed. No Displays over 8 feet in height will be permitted without prior approval.
10. Failure to comply with the above terms and conditions may result with in expulsion from Reggae fest and forfeiture of any application fees.
